Report on the verification of allegation of price gouging of basic commodities by grocers of Dangrina following the recent Dechencholing flood

A. Background

The Competition and Consumer Affairs Authority (CCAA) conducted a two-day inspection on 12 & 14 August, 2024, following the receipt of information on suspected price gouging by business firms in the Dangrina, which had remained cut-off from Thimphu in the wake of the Dechencholing flood on August 10, 2024.

It is necessary to monitor the market prices during such times. Past experience especially during COVID pandemic lockdowns have shown that businesses tend to exploit disruptions in the market for greater profit; which harms consumers whose normal lives are already affected by natural disasters.

B. Surveillance, results & discussion

The CCAA Team inspected 13 grocers in the locality and collected prices of 20 most essential commodities. The average selling prices (ASP) in Dangrina were compared with the average prices collected from five popular grocers located in the Thimphu town (Table I)

There results varied in that prices were up and down depending on the commodity. However, there was no consistent patterns of higher prices indicate of price exploitation by grocers in Dangrina. However, most grocers in Dangrina did not adequately display prices of goods and were directed to prominently display prices of all goods in the future for the benefit of consumers.

C. Conclusion

Exploitation by unethical businesses are common phenomena during natural disasters when supply of goods is disrupted due to breakage in the supply chain. It is therefore imperative to surveil prices and take actions as per existing consumer protection laws during such times.
